PROJECT SUMMARY

Bayview responded to an emergency response request from its customer to assist in a coordinated clean-up effort related to the oil spill incident off the coast of Huntington Beach. A Unified Incident Management Team that included the US Coast Guard, California Department of Fish and Wildlife, and Amplify Energy Corporation directed the clean-up efforts. Immediate closure to Huntington Beach was necessary to limit public access to oil-impacted areas, due to the toxicity of the oil and ongoing cleanup efforts.

Our project consisted of Bayview immediately deploying 4 Foreman, 36 Technicians and 4 crew Vehicles around the clock for 8 working days to implement oil containment efforts. The work continued through the re-opening of the Public Beach ahead of the projected schedule.

The Unified Command announced that approximately 5,544 gallons of oil has been recovered from the water and 12,160 feet of boom had been deployed. Huntington Beach was re-opened to the Public on October 8, 2021.

PROJECT SUMMARY

This project of general contractor TRC, located in San Francisco, was completed by Bayview Environmental and worth over \$1,000,000. The power plant contained 1,002,000 square feet of property with a 206-megawatt, natural gas burning steam turbine and three 52-megawatt peaking power diesel generators, as well as tanks for storing liquid fuel. Our employees performed extensive hazardous material remediation inside these large tanks, removing the residue that had accumulated from the plant's operations: with the main hazardous materials being polycyclic aromatic hydrocarbons (PAHs) and volatile organic compounds (VOCs). The tanks were subsequently pressure-washed to complete the cleaning. The focus then moved to the tank exteriors, where the Bayview team handled the removal and remediation of thermal system insulation.

PROJECT SUMMARY

Bayview Environmental Services completed the asbestos cable abatement at the San Onofre Power Generating Station for its Decommissioning.

This project involved several challenges including extremely stringent access requirements, additional environmental hazardous training, protocols and PPE, difficult work area access due to elevated and congested infrastructure as well as stringent COVID-19 procedures.

The scope of work consisted of the removal and packaging for disposal of 27 miles of asbestos braided cables that are found throughout the plant and included the cleaning of asbestos surface dust from the 370,000 square foot facility. The contract was valued at over \$7.7 million dollars and was completed on schedule.

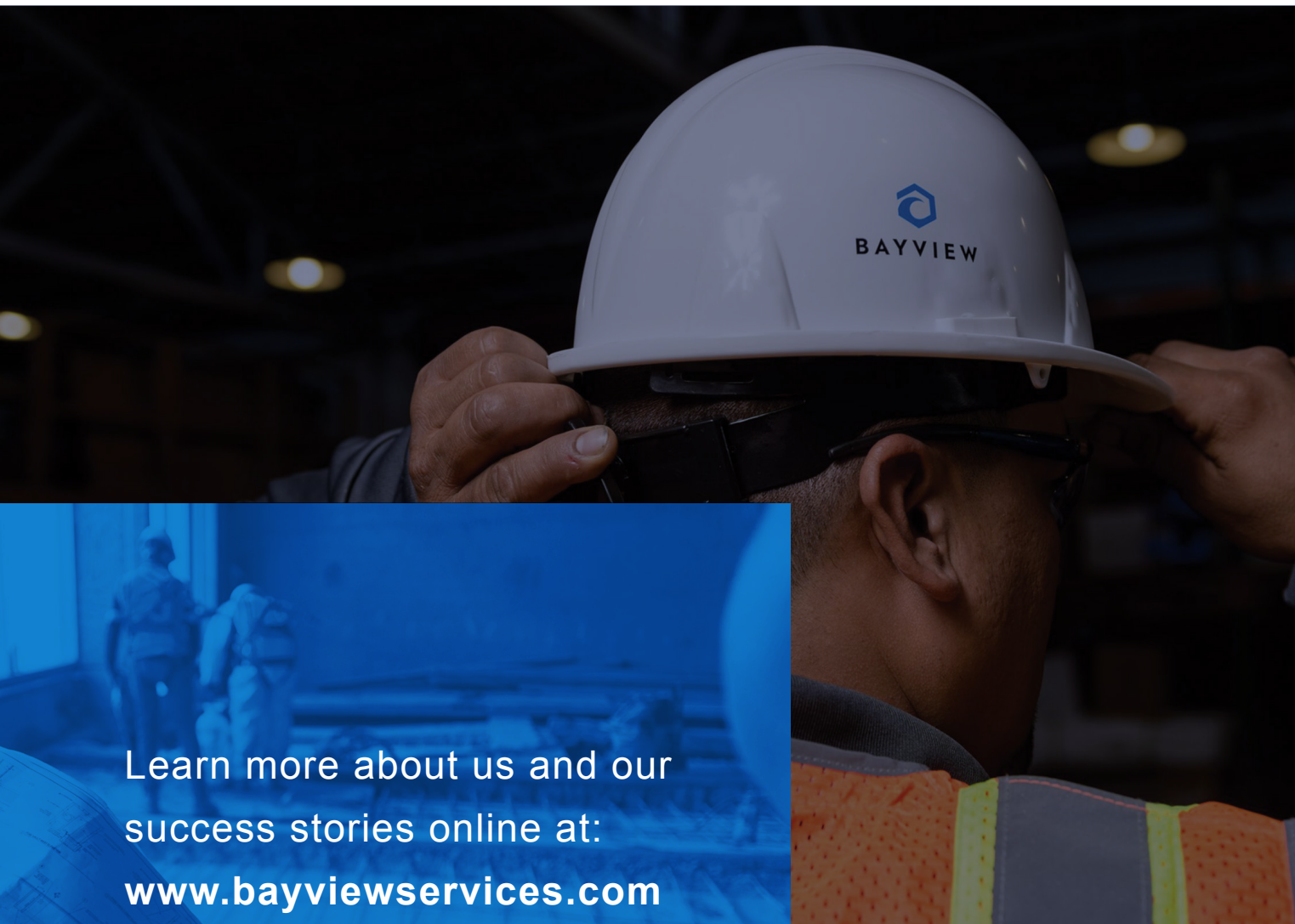
