Bayview Environmental Services is currently performing asbestos remediation for the decommissioning of the 640-megawatt electric power generating station composed of four conventional natural gas-fired electric steam generating units. (Units 1 through 4) Unit 5 is a peaking natural gas-fired simple-cycle combustion turbine generation unit. Units 1, 2, and 5 were retired in 2003 and Units 3 and 4 in 2016. The project also includes an administration/office building, maintenance shop/storage buildings, chemical building, fire hose shacks and main control rooms located within Units 3 and 4. Our scope of work covers removing thousands of feet of TSI piping, boiler insulation and fire bricks throughout the Units as well as removing an abundance of transite siding and piping located all over the site. This specific project requires a large work force and access to some of the areas is extremely limited. Our highly trained personnel will be working off scaffolding that spans nearly 135 feet high with confined space along with all the surrounding elements that presents a challenge that few companies in our industry can execute. Our Southern California branch is pleased to be selected as the contractor for this project as it encompasses many technical challenges involved with our trade.

This project involved the renovation of the International Arrivals Terminal Building located at the Oakland Airport in Oakland, California. Two walls of the building were completely removed, and the building was expanded out to increase the overall size of the structure. In addition, the entire building was renovated, including electrical and structural upgrades. Interior finishes were completely removed and upgraded. Restrooms were completely removed and upgraded, and all of the luggage carousels were removed and upgraded. All of this work was performed with the building remaining occupied and fully functional, and since this was the International Terminal the building was under high security, which required special access badges.

Bayview responded to an emergency response request from its customer to assist in a coordinated clean-up effort related to the oil spill incident off the coast of Huntington Beach. A Unified Incident Management Team that included the US Coast Guard, California Department of Fish and Wildlife, and Amplify Energy Corporation directed the clean-up efforts. Immediate closure to Huntington Beach was necessary to limit public access to oil-impacted areas, due to the toxicity of the oil and ongoing cleanup efforts.

Our project consisted of Bayview immediately deploying 4 Foreman, 36 Technicians and 4 crew Vehicles around the clock for 8 working days to implement oil containment efforts. The work continued through the re-opening of the Public Beach ahead of the projected schedule.

The Unified Command announced that approximately 5,544 gallons of oil has been recovered from the water and 12,160 feet of boom had been deployed. Huntington Beach was re-opened to the Public on October 8, 2021.



The Pier 70 Building 12 project consists of asbestos and lead abatement, MEP and selective demo within a historical building. This project began with the decontamination of the entire building to allow access to other trades. The lead abatement scope consisted of removal of approximately 30,000 sq.ft. of paint on the columns, while the ACM removal process was of approximately 58,000 sq. ft. of roofing material. The MEP and structural demolition was approximately 30,000 sq.ft. This project included stringent requirements for local hiring and local business involvement. The current Bayview Environmental contract is valued at over \$3,200,000.




