

Bayview Environmental Services, Inc. was awarded the mold remediation and demolition project at the Intel facility located in Santa Clara California. The scope of work was to remove moldy drywall which had impacted the entire 3 story building known as Building D2. The scope included the removal of the mechanical systems, including the main supply fans on the upper floor (Fan Deck) and all piping, electrical conduits, HVAC ducting, low voltage wiring, fire sprinkler systems, raised floors, and all interior finishes. The project was a combination project performed with Environmental and Demolition teams working in sequence to remove the necessary mechanical systems prior to the Environmental team coming in to prepare the mold containments and remove the moldy drywall materials. The \$3 million + dollar project was scheduled for 12 weeks. Several change orders were added to the contract including removal of overhead secondary steel support systems.





The project included interior soft demolition, interior slab demolition, demolition of certain existing stairs and elevators, and the cutting of new slab and floor openings. In addition, the project required the removal of exterior windows, storefronts, facades, and roof-top equipment demolition. There were areas of the project that were abated of certain hazardous materials to support the demolition scope. The project also required the salvage and recycling of components in order to meet the project's LEED requirements.

This project required the concurrent interior demolition of 400,000 square feet of finishes from three buildings being renovated on a fast track for the world's largest search-engine company. Bayview Demolition (formerly Demo Masters) was tasked with providing the owner and general contractor with a 95% reuse/recycle rate while performing the work on an accelerated schedule. The materials diverted from landfills and recycled or reused were 400,000 square feet of ceiling tile, 200,000 square feet of carpet tile, 2,000 tons of metal, and hundreds of pieces of doors, windows casework, and fixtures. Demo Masters worked closely with the general contractor to react quickly to all of the changes required by the architect, and provided the reuse specialist with all of the materials requested so the owner could certify the renovation as LEED gold/platinum.



The scope of this modernization included accessibility compliance, new building systems, repurposing of some spaces, new conveying systems and new finishes. Notable site work included new PE stations, new softball/baseball field, new parking, rehabilitation of existing parking, new main entrance, landscaping, site and perimeter fencing. Phase 2 and phase 3 of the scope included the demolition of the existing gym building, the auditorium building and Randolph Hall. We also removed 3 shop buildings and 27 portable classroom buildings.
